**NOW, THEREFORE, BE IT RESOLVED,** by the Governing Board of the Willows Unified School District that:

- 1. It is the policy of this Board that when a Board Member is unable to attend a regular/special meeting of the Board because (a) he/she was performing services outside the meeting for the school district; or (b) he/she was ill; or (c) he/she was on jury duty, or (d) the absence was due to a hardship deemed acceptable by the Board, that absence shall be excused.
- 2. In light of the policy set forth above, the Board Member shall receive his/her compensation for services during the month in which the excused absence occurred.
