

**WILLOWS UNIFIED SCHOOL DISTRICT  
RESOLUTION FOR SUFFICIENCY OF INSTRUCTIONAL MATERIALS  
2011-12  
RESOLUTION NO. 2011-12-01**

**WHEREAS**, the local governing board of Willows Unified School District, in order to comply with the requirements of Education Code section 60119 held a public hearing on September 1, 2011, 7:00 pm which is on or before the eight week of school and which did not take place during or immediately following school hours, which is on or before the eight week of school, and;

**WHEREAS**, the local governing board provided at least ten days notice of the public hearing posted in at least three public places within the district that stated the time, place and purpose of the hearing, and;

**WHEREAS** the local governing board encouraged participation by parents, teachers, members of the community and bargaining unit leaders in the public hearing, and;

**WHEREAS** information provided at the public hearing and to the local governing board at the public meeting detailed the extent to which textbooks and instructional materials were provided to all students, including English learning, in the Willows Unified School District, and;

**WHEREAS** the definition of "sufficient textbooks or instructional materials" means that each pupil, including each English learner, has a standards-aligned textbook and/or instructional materials to use in class and to take home, which may include materials in a digital format but shall not include photocopied sheets from only a portion of a textbook or instructional materials copied to address a shortage, and; whereas between the 2008-09 through the 2012-13 fiscal years, the definition of "sufficient textbooks or instructional materials" also means that all pupils who are enrolled in the same course within the Willows Unified School District, have standards-aligned textbooks or instructional materials from the same adoption cycle, and;

**WHEREAS**, sufficient textbooks and instructional materials were provided to each student, including English learners, and are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in the following subjects:

- Mathematics
- Science
- History-social science
- English/language arts, including the English language development components of an adopted program

**WHEREAS**, sufficient textbooks or instructional materials were provided to each pupil enrolled in foreign language or health classes, and;

**WHEREAS**, sufficient laboratory science equipment was available for science laboratory classes offered in grades 9-12, inclusive;

**NOW, THEREFORE, BE IT RESOLVED** that for the 2011-12 school year, the Willows Unified School District has provided each pupil with sufficient textbooks and instructional materials consistent with the cycles and content of the curriculum frameworks.
