Dr. Geivett explained that the District should establish tie-breaking criteria when certificated employees are hired on the same date in order to have a more legally defensible seniority list. The District has researched this matter with their legal counsel and looked at other school districts' policies and procedures. He explained the different criteria to the Board. He stated that the last item states that if any employees end up with the same number of points, a lottery drawing is held which is what our district has done for approximately the past 40 years. In an effort to conform to the requests of WUTA and to be as legal as possible, the District's research culminated with the attached tie-breaking criteria. Mr. Geiger moved, seconded by Mr. Ward, to approve the Criteria to Determine the Order of Termination among Certificated Employees with the Same Date of Paid Service. Mr. Parisio thanked Dr. Geivett for his hard work in completing this task. The motion passed with 3 yes votes.
