# (MES) Mrs. Brown reported:

- Enrollment is 648 students.
- Painting of the 100 Wing and the cafeteria is finished.
- Thank you to Steven Permann and the maintenance team. They are doing a great job.
- The instructional coaches have been going out and especially working with the new teachers.
- The First 5 organization has been helping with the Kindergarten classes.
- Cinnamin Morton, with GCOE, presented CLOSE Reading to the teachers at the Collaboration Day.
- Condolences to Mr. Ward and the Ward family on behalf of MES.

## (WIS) Mr. Sailsbery reported:

- Tuesday, December 8<sup>th</sup>, instructional coaches went out to work with new teachers.
- Jackie Campos, Autism Specialist with GCOE, made a presentation to the staff at the Collaboration Day on how to work with autistic children.

## (WHS) Mr. Humphreys reported:

- After Christmas break, WHS will be utilizing information that Ellen Hamilton presented regarding instructional rigor and how teachers can self-assess that in their classes.
- Some adjustments to Plus Period will be made in the next semester, so students can actually go the class they are struggling in for help. The Board requested Mr. Humphreys bring back information to the Board regarding numbers of students in Plus Period, how it's benefited the students; whether the numbers are increasing or decreasing; if students are taking advantage of it to help bring their grades up; and a comparison of students' grades from last year to this year.
- Mr. Parisio asked about getting a new scoreboard/clock for the WHS gym. The old one is not working. The Boosters will be meeting with the Superintendent to discuss purchasing new scoreboards.

## (WCHS) Dr. Geivett reported:

# 5.3 Associated Student Body Report – Lisa Pence reported:

- FFA has increased in meeting attendance. There are over 60 students who have turned in paperwork to show livestock at the Glenn County Fair this year.
- A food drive has been going on since the beginning of November.
- WHS is currently deciding on a theme for Winter Homecoming, which will be January 29<sup>th</sup>.
- Mr. Geiger asked about the students' perspective regarding the Plus Period. Ms. Pence said some students have an attitude that they are always going to be in Plus Period. Some students figure out what they need to do get out. Students don't generally use it for a "study hall" time.

## 5.4 Director of Business Services – Debby Beymer reported:

- Mrs. Beymer distributed an Enrollment Report showing enrollment numbers from this time last year to today. WUSD is down 8 students, and each student generates approximately \$7,500.
- WUSD received its Draft Independent Audit report. There was one non-monetary finding that is tied to the SARC, and it has already been corrected.

# 5.5 Director of State & Federal Programs – Ellen Hamilton reported:

- Mrs. Hamilton went over the EL Master Plan.
- The AYP/API scores have not been released yet. That information will be available at the January meeting.
- The state is looking into making the LCAP the new LEA plan.
- Every Student Succeeds Act (ESSA) was signed into law today by President Obama beginning in the 2017-18 school year. This replaces the Elementary and Secondary Education Act, currently known as No Child Left Behind.

## 5.6 Superintendent – Dr. Geivett reported:

- The new District website is up and going.
- WUSD signed a contract with CatapultEMS and will have trainings next month.
- December 8<sup>th</sup> was the Day of the Volunteer. Staff members sent out over 60 thank you notes to various people who have helped our District.
- Commended Debby Beymer and staff for a positive audit report.
- WUSD is working on getting bids for the roofing project at MES. Requests for bids will be advertised on December 5<sup>th</sup> and December 12<sup>th</sup>. The intent is for the work to be done the summer of 2016.
- There is a meeting on December 16<sup>th</sup> for the Rural Professional Learning Project (RLPN) with PIVOT Learning to study implementing technology in the classroom. District staff members will be learning how to use the software program we will be using to compile data.
- Every Student Succeeds Act (ESSA) more information coming in the future, but it mirrors what California is doing with the LCFF.
- There is a possibility of a statewide bond election in November 2016. If that bond were to pass, that would give the state of California additional funds to provide funding to districts for construction on facilities. If we are in line for that funding, it is feared that we won't have the matching portion of money to do the facilities work that we need to do. We may want to consider doing another local bond election.
