SHORT TERM CONTRACT FOR PUBLIC WORK PROJECT: MURDOCK RE-ROOFING PROJECT 2016

THIS CONTRACT made and entered into on <u>February 4</u>, 2016, by and between WILLOWS UNIFIED SCHOOL DISTRICT (hereinafter "District") and GEORGE ROOFING hereinafter (hereinafter "Contractor") (the District and Contractor are also collectively referred to herein as "Parties" and individually as "Party").

WITNESSETH: The parties do hereby contract and agree as follows:

A. SPECIFIC TERMS AND CONDITIONS

1. The Work

- 1.1 The Contractor shall furnish to the District for the total contract price of four hundred and fifty thousand two hundred Dollars (\$450,200.00) the Work specified in the Bid Form and related bid documents attached as Exhibit A which is incorporated herein as if fully set forth.
- 1.2 The Contractor shall meet all of the requirements set forth in Exhibit A and all of the conditions for the Work set forth in Exhibit A shall apply to the Contractor's performance of his obligations under this Contract.

2. Term

- 2.1 The Effective Date of this Contract shall be the date it has been signed by both Parties and approved by the governing Board of the District. This Contract shall terminate when the obligations of both Parties which are set forth therein are fulfilled.
- 2.2 The Work pursuant to this Contract shall begin on Monday, May 16, 2016 and shall be completed on or before Friday, July 22, 2016.
- 2.3 Liquidated damages as set forth in Exhibit A shall apply should Contractor fail to complete the Work within the period set forth in paragraph 2.2 above.
- 3. The Contractor shall not commence Work under this Contract until:
 - 3.1 a) the insurance required under Paragraph 23 of the Terms and Conditions set forth below has been obtained; b) satisfactory proof of such insurance has been submitted to the District; and c) said insurance has been approved by the District.
 - 3.2 The Contractor has provided to the District:
 - 3.2.1 a performance bond for the Work; and

- 3.2.2 a payment bond for the Work; and
- 3.2.3 documentation of all of the required warranties for the Work set forth in Exhibit A.

4. Payment Schedule

- 4.1 Payment for the Work shall be made in a lump sum upon final completion of the Work and the District's written approval of the Work in accordance with the terms of this Contract (which approval shall not be unreasonably withheld).
- 4.2 Upon approval of the Work as set forth in paragraph 4.1 above, the Contractor shall provide to the District a final detailed invoice for the Work, along with a release of all liens from all subcontractors who performed or provided material for the Work. The District shall have no obligation to pay for the Work until the Contractor provides such lien release(s).
- 4.3 The Contractor's invoice shall detail the cost of labor and materials used in performing the Work.
- 5. Inspection and final approval of the Work shall be performed by the Supervisor of Maintenance (District-wide Maintenance Lead III) for the District, or his authorized representative.
- 6. In addition to the warranties required in Exhibit A, the Contractor shall guarantee all labor and materials used in the performance of this Contract against all defects in material or workmanship, irrelevant of the cause of the defect, for a period of one (1) years from the date of final written approval by the District. This provision shall survive the termination of the Contract.
- 7. In case of conflict between this Contract and Exhibit A, the terms of this Contract shall govern.

B. GENERAL TERMS AND CONDITIONS

1. SITE EXAMINATION

Contractor must examine the site where the Work shall be performed and certify all measurements, specifications and conditions affecting the Work to be performed at the site. Contractor warrants that Contractor has made such site examination as deemed necessary as to the condition of the site, it's accessibility for materials, workmen and utilities and ability to protect existing surface and subsurface improvements. No claim for allowance of time or money will be allowed as to such matters or for any other undiscovered conditions on the site.

2. EQUIPMENT AND LABOR

Contractor shall furnish all tools, equipment, apparatus, facilities, transportation, labor, and material necessary to furnish the Work, which shall be performed at such times and places as

directed by and subject to the approval of the authorized District representative designated in this Contract.

3. SUBCONTRACTORS

Contractor agrees to bind every subcontractor by terms of this Contract as far as such terms are applicable to subcontractor's work on the Work. If Contractor subcontracts any part of this Contract, Contractor shall be fully responsible to the District for acts and omissions of his subcontractor and of persons either directly or indirectly employed by himself. Nothing contained in the Contract documents shall create any contractual relations between any subcontractor and the District.

4. SAFETY AND SECURITY

- 4.1 It shall be the responsibility of the Contractor to ascertain from the District the rules and regulations pertaining to safety, security and driving on school grounds, particularly when students are present.
- 4.2 Contractor, and Contractor's employees, subcontractors, and others under Contractor's control, shall abide by the District's rules and regulations at all times while on District property.

5. DEFAULT BY CONTRACTOR

- 5.1 If Contractor, or any subcontractor or vendor, fails to deliver any article or service or shall deliver any article or service which does not conform to the Service specifications, the District may, upon five (5) business days' prior written notice describing the default, at its option, annul and set aside the contract entered into with said Contractor, subcontractor or vendor, either in whole or in part, and make and enter into a new contract in such manner as seems to the Board of Education to be the best advantage of the District in accordance with the law.
- 5.2 Any failure for furnishing such articles or service by reason of the failure of the Contractor, subcontractor or vendor, as above stated, shall be a liability against the Contractor and his sureties.
- 5.3 The District Board of Education reserves the right to cancel any articles or services which the Contractor may be unable to furnish because of economic conditions, governmental regulations, or other similar causes beyond the control of the Contractor, provided that satisfactory proof is furnished to the Board of Education, if requested.

6. AMENDMENTS AND MODIFICATION

This Contract may be amended or modified only by mutual agreement in writing signed by both Parties.

7. WORKERS

Contractor shall at all times enforce strict discipline and good order among his or her employees and shall not employ any unfit person or anyone not skilled in work assigned to him or her to perform the Work under this Contract. Any person in the employ of the Contractor whom the District may deem incompetent or unfit shall be dismissed from the job site and shall not again be employed at site without written consent from the District.

8. SUBSTITUTIONS

No substitutions of materials from those specified in the Work Specifications shall be made without the prior written approval of the District.

9. CONTRACTOR SUPERVISION

Contractor shall provide competent supervision of personnel employed on the job site, use of equipment, and quality of workmanship.

10. CLEAN-UP

The Contractor shall remove all debris resulting from the Work from the premises. The Contactor shall ensure that the job site is in order at all times when work is not actually being performed and that it is maintained in a reasonably clean condition.

11. ACCESS TO WORK

The District representatives shall at all times have access to the work site wherever the Work is in preparation or progress. The Contractor shall provide safe and proper facilities for such access.

12. PROTECTION OF WORK AND PROPERTY

The Contractor shall erect and properly maintain at all times, as required by conditions of progress of the Work, all necessary safeguards, signs, barriers, lights, and watchmen for protections of workmen and the public, and shall post danger signs warning against hazards created by such features in the course of construction. In an emergency affecting life, or safety of life or of work or of adjoining property, the Contractor, without special instruction or authorization from the District, is permitted to act at his or her discretion to prevent such threatened loss or injury.

13. OCCUPANCY

The District reserves the right to occupy buildings at any time before formal Contract completion and such occupancy shall not constitute final acceptance or approval of any part of the work covered by this Contract nor shall such occupancy extend the date specified for substantial completion of the work.

14. ASSIGNMENT OF CONTRACT AND PURCHASE ORDER;

The Contractor shall not assign, or transfer by operation of law or otherwise, any or all of the Contractor's rights, burdens, duties, or obligations under this contract without the prior written consent of the District.

15. FORCE MAJEURE CLAUSE

The Parties to the Contract shall be excused from performance of their obligations thereunder during the time, and to the extent, that they are prevented from obtaining, delivering, or performing by act of God, fire, strike, loss or shortage of transportation facilities, lock-out, commandeering of materials, products, plants or facilities by the government, when satisfactory evidence thereof is presented to the other Party, provided that it is satisfactorily established that the non-performance is not due to the fault or neglect to the Party not performing.

16. HOLD HARMLESS AGREEMENT

The Contractor shall save, defend, hold harmless and indemnify the District from and against any and all losses, damage, liabilities, claims and costs of whatsoever kind and nature for injury to death of any person and for loss or damage to any property occurring in connection with or in any way incident to or arising out of the occupancy, use, service, operations, or performance of Work under the terms of this Contract, resulting in whole or in part from the negligent acts or omissions, or the willful misconduct, of the Contractor, any subcontractors, or any employee, agent or representative of Contractor and/or its subcontractors. This provision shall survive the termination of this Contract.

17. PAYMENT

- 17.1 Notwithstanding the terms of paragraph 4 of the Specific Conditions, the Contractor shall render invoices for materials delivered or services performed under the Contract on a biweekly basis. These invoices shall be for informational purposes only.
- 17.2 The District shall make payment for materials, supplies or other services furnished under this Contract in lump sum on completion of the work within thirty (30) days after delivery to and approval by the authorized District representative of all invoices and other documentary evidence reasonably required by the District (which approval shall not be unreasonably withheld).
- 17.3 The District's obligation to pay the Contractor is subject to the provisions of paragraph 4 of the Specific Conditions above.

18. PERMITS AND LICENSES

The Contractor and all of the Contractor's employees, agents, and subcontractors shall secure and maintain in force, at no cost to the District, such licenses and permits as are required by law, in connection with the furnishing of materials, supplies, or services for the Work.

19. CONTRACTOR NOT OFFICER, EMPLOYEE, OR AGENT OF DISTRICT

- 19.1 While engaged in carrying out other terms and conditions of the Contract, the Contractor is an independent Contractor, and not an officer, employee, agent, partner, or joint venture of the District. The Parties acknowledge that this Contract does not create an employer-employee relationship.
- 19.2 Contractor is responsible for withholding or deducting any taxes required to be withheld or deducted from any payments made by the District to Contractor pursuant to this Contract.

21. ANTI-DISCRIMINATION

It is the policy of the District that in connection with all work performed under construction and purchasing contracts, there be no discrimination against any employee engaged in the work because of race, color, sex, ancestry, national origin, or religious creed, and therefore, the Contractor agrees to comply with the applicable Federal and California Laws, including but not limited to: the California Fair Employment Practice Act, beginning with Labor Code, Section 1410 and Labor Code, Section 1735. In addition, the Contractor agrees to require such compliance by all subcontractors employed on the work by him or her.

22. LABOR CODE

The Contractor shall comply with the applicable provisions of the California Labor Code, Division 3, Part 7, Chapter 1, Articles 1-5, including the payment of the general prevailing wage rages for public works projects of more than One Thousand Dollars (\$1,000). Copies of the prevailing wage rate of per diem wages are available from the Supervisor of Maintenance.

23. CONTRACTOR'S AND SUBCONTRACTOR'S INSURANCE

The Contractor shall not commence work under this Contract until he or she has obtained the insurance required under this paragraph and satisfactory proof of such insurance has been submitted to the District and said insurance has been approved by the District. Except for worker's compensation insurance, the policy shall not be amended or modified and the coverage amount shall not be reduced without the District's prior written consent. The District shall be named as an additional insured and be furnished thirty (30) days written notice prior to cancellation. The Contractor shall not allow any subcontractor, employee or agent to commence work on this contract or any subcontract until the insurance required of the Contractor, subcontractor or agent has been obtained and the conditions set forth in paragraph 3 of the Specific Conditions above have been met.

23.1 WORKER'S COMPENSATION INSURANCE

The Contractor shall procure and shall maintain during the life of this contract Worker's Compensation Insurance on all of his or her employees to be engaged in work on the project under this contract and in case of any such work sublet, the contractor shall require the subcontractor similarly to provide Worker's Compensation Insurance for all of the latter's employees to be engaged in such work unless such employees are covered by the protection afforded by the Contractor's Worker's Compensation Insurance.

23.2 CONTRACTOR'S PUBLIC LIBILITY AND PROPERTY DAMAGE INSURANCE

- 23.2.1 The Contractor shall procure and shall maintain during the life of this contract, Contractor's Public Liability Insurance in an amount not less than \$1,000,000 for injuries, including accidental death to any one person, and subject to the same limit for each person, in an amount not less than \$1,000,000 on account of one accident, and Contractor's Property Damage Insurance in an amount no less than \$1,000,000. Any subcontractor employed in connection with the work shall maintain such insurance unless the Contractor's insurance covers the subcontractor and its employees.
- 23.2.2 Prior to the commencement of the Work, the Contractor shall provide to the District certificates and endorsements of insurance naming the District as an additional insured on the insurance policies required in paragraph 23.2.1.

24. COMPLIANCE WITH LAWS

- 24.1 Contractor shall give all notices and comply with the laws, ordinances, rules and regulation bearing on conduct or the Work as indicated or specified in this Contract or as required by law. If Contractor observes that any of the Work required by this Contract is in conflict with any such laws, ordinances, rules or regulations, Contractor shall notify the District, in writing, and at the sole option of the District, any necessary changes to the scope of Work shall be made and this Contract shall be appropriately amended in writing. In the alternative, the District may terminate this Contract effective upon Contractor's receipt of a written termination notice for the District.
- 24.2 If Contractor performs any Work knowing it to be in violation of such laws, ordinances, rules or regulations, Contractor shall bear all costs arising therefrom.

25. TIME IS OF THE ESSENCE

Time is of the essence in the performance of and compliance with each of the provisions and conditions of this Contract.

26. GOVERNING LAW AND VENUE

This Contract shall be governed by and construed in accordance with the laws of the State of California. Venue shall be in Glenn County, California.

27. ATTORNEYS' FEES

If any action is brought by either Party against the other Party hereunder, the prevailing Party shall be entitled to recover from the other Party reasonable attorneys' fees, costs and expenses incurred in connection with the prosecution or defense of such action.

28. PROVISIONS REQUIRED BY LAW DEEMED INSERTED

Each and every provision of law and cause required by law to be inserted in this Contract shall be deemed to be inserted herein and this Contract shall be read and enforced as though it were included therein.

29. ASBESTOS HAZARD EMERGENCY RESPONSE ACT (AHERA)

All contract work that is performed for the District by outside Contractors or workers must meet all of the regulations that have been set forth in the AHERA rule. This means that all work which could disturb the integrity of any Asbestos containing Building Material (A.C.B.M.) needs to be approved by the District. This refers to the sawing, grinding, cutting, or drilling of any A.C.B.M. in occupied areas of District buildings.

30. SMOKING

No smoking is allowed on District property and said policy is to be strictly enforced by the Contractor.

31. FINGER PRINTING

AB2102 requires that Contractors meet one of the following criteria;

- 31.1 Employer and Employees who may come into contact with pupils have submitted finger prints to and been cleared by the Department of Justice.
- 31.2 A physical barrier is installed between the pupils and the work site.
- 31.3 Continuous supervision of employees is provided by a finger printed Contractor employee who has received Department of Justice clearance.
- 31.4 Continuous supervision of employees is provided by a District employee, at the expense of the Contractor.

32. COUNTERPARTS

This Contract may be executed in counterparts, each of which shall be deemed an original, but all of which, together, when signed by all of the Parties hereto, shall constitute one and the same instrument. An electronic or facsimile signature shall be as valid as an original.

33. APPROVAL OF GOVERNING BOARD

This Contract shall not be binding upon the District until the District's Governing Board has approved all the terms and conditions contained herein.

34. WAIVER

Waiver of a breach or default under this Contract shall not constitute a continuing waiver of a subsequent breach of the same or any other provision under this Contract.

35. ENTIRE AGREEMENT

This Contract represents the entire agreement between the Parties concerning the Work and supersedes all prior negotiations, representations or agreements, either written or oral related to the Work.

36. STANDARD OF CARE

The Contractor shall provide and perform the Work specified in <u>Exhibit A</u> in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently operating under similar circumstances, who are specially qualified to provide the services required by the District.

39. SEVERABILITY

In the event that any provision of this Contract is construed to be illegal or invalid for any reason, the illegality or invalidity shall not affect the remaining provisions hereof, but such illegal or invalid provision shall be fully severable, and this Contract shall be construed and enforced as if such illegal or invalid provision had never been included herein, unless to do so would frustrate the intent and purpose of the Parties in entering into this Contract.

40. NOTICE

Any notice under this Contract may be given to the following contacts by: (1) personal service; (2) registered U.S. mail with return receipt requested; (3) courier with tracking and proof of delivery requested; 4) electronic mail; or 5) facsimile. Notice shall be effective on the date it is received.

- B. Special Project Warranty: Provide specified warranty for the Project, executed by the authorized agent of the Manufacturer.
- C. Roofing Maintenance Instructions. Provide a manual of manufacturer's recommendations for maintenance of installed roofing systems.
- D. Insurance Certification: Assist Owner in preparation and submittal of roof installation acceptance certification as may be necessary in connection with fire and extended coverage insurance on roofing and associated work.
- E. Demonstration and Training Schedule: Provide a schedule of proposed dates and times for instruction of Owner's personnel in the maintenance requirements for completed roofing work. Refer to Part 3 for additional requirements.

1.6 QUALITY ASSURANCE

1.7 PRE-INSTALLATION CONFERENCE

- B. Require attendance of installer of each component of associated work, installers of deck or substrate construction to receive roofing work, installers of rooftop units and other work in

and around roofing that must precede or follow roofing work (including mechanical work if any), Owner, roofing system manufacturer's representative, and other representatives directly concerned with performance of the Work:

- 1. Review foreseeable methods and procedures related to roofing work, including set up and mobilization areas for stored material and work area.
- 2. Tour representative areas of roofing substrates (decks), inspect and discuss condition of substrate, roof drains, curbs, penetrations and other preparatory work performed by others.
- 3. Review structural loading limitations of deck and inspect deck for loss of flatness and for required attachment.
- 4. Review roofing system requirements specifications and other contract documents.
- 5. Review required submittals both completed and yet to be completed.
- 6. Review and finalize construction schedule related to roofing work and verify availability of materials, installer's personnel, equipment and facilities needed to make progress and avoid delays.
- 7. Review required inspection, testing, certifying and material usage accounting procedures.
- 8. Review weather and forecasted weather conditions and procedures for coping with unfavorable conditions, including possibility of temporary roofing (if not mandatory requirement).
- 9. Record discussion of conference including decisions and agreements (or disagreements) reached and furnishes copy of record to each party attending. If substantial disagreements exist at conclusion of conference, determine how disagreements will be resolved and set date for reconvening conference.
- 10. Review notification procedures for weather or non-working days.
- C. The Owner's Representative will designate one of the conference participants to record the proceedings and promptly distribute them to the participants for record.
- D. The intent of the conference is to resolve issues affecting the installation and performance of roofing work. Do not proceed with roofing work until such issues are resolved to the satisfaction of the Owner.

1.8 DELIVERY, STORAGE AND HANDLING

- A. Deliver products to site with seals and labels intact, in manufacturer's original containers, dry and undamaged.
- B. Store and handle roofing sheets in a dry, well-ventilated, weather-tight place to prevent moisture exposure. Store rolls of felt and other sheet materials on pallets or other raised

- surface. Stand all roll materials on end. Cover roll goods with a canvas tarpaulin or other breathable material (not polyethylene).
- C. Do not leave unused materials on the roof overnight or when roofing work is not in progress unless protected from weather and other moisture sources.
- D. Secure all material and equipment on the job site. If any material or equipment is stored on the roof, assure that the integrity of the deck is not compromised at any time. Damage to the deck caused by the Contractor's actions will be the sole responsibility of the Contractor, and the deck will be repaired or replaced at his expense.

1.9 MANUFACTURER'S INSPECTIONS

- A. When the Project is in progress, the roofing system manufacturer will provide the following services at no additional cost to the Owner:
 - 1. Report progress and quality of the work as observed with weekly on-line reports. Reports are due every Monday on-line to the Owner; reports to include photos of work in progress and completed work.
 - 2. Job site inspections by a full time employee of the manufacture a minimum of 3 days per week with photo documentation.
 - 3. Report to the Owner in writing any failure or refusal of the Contractor to correct unacceptable practices called to the Contractor's attention.
 - 4. Confirm after completion that manufacturer has observed no application procedures in conflict with the specifications other than those that may have been previously reported and corrected.

1.10 PROJECT CONDITIONS

- A. Proceed with roofing work only when existing and forecasted weather conditions will permit a unit of work to be installed in accordance with manufacturer's recommendations and warranty requirements.
- B. Do not apply roofing insulation or membrane to damp deck surface.
- C. Do not expose materials subject to water or solar damage in quantities greater than can be weatherproofed during same day.

1.11 SEQUENCING AND SCHEDULING

- A. Sequence installation of roofing with related units of work specified in other Sections to ensure that roof assemblies, including roof accessories, flashing, trim and joint sealers, are protected against damage from effects of weather, corrosion and adjacent construction activity.
- B. Complete all roofing field assembly work each day. Phased construction will not be accepted.

Warranty shall be a single source warranty from one manufacturer (Multiple warranties will not be accepted) covering: modified bitumen roofing, wall panels and flashings.
- B. Warranty provider to be the same as phase one 2015 construction to avoid warranty issues.
- C. Installer will submit a (1) one year warranty to the membrane manufacturer with a copy directly to Owner.

1.13 DESIGN AND PERFORMANCE CRITERIA

- A. Uniform Wind Uplift Load Capacity
 - 1. Installed roof system shall withstand negative (uplift) design wind loading pressures complying with the following criteria. Attachment shall be installed exactly as given in Part 3. (To be included with bid documents)
 - a. Design Code: ASCE 7-10, Method 2 for Components and Cladding.
 - b. Category III Building with an Importance Factor of 1.15.
 - c. Safety Factor: 1.650 after any load reduction or material stress increase.
 - d. Wind Speed: 120 MPH
 - e. Ultimate Pullout Value: 730 lbs.
 - f. Exposure Category: C
 - g. Design Roof Height: 10 feet.
 - h. Minimum Building Width: 60 feet.
 - i. Roof Pitch: 1/2 inches per foot.
 - j. Topographic Factor: 1.00
 - 1) Roof Area Design Uplift Pressure:
 - 2) Zone 1 Field of roof: 20.6
 - 3) Zone 2 Eaves, ridges, hips and rakes
 - 4) Zone 3 Corners

PART 2 — PRODUCTS

2.1 PRODUCTS, GENERAL

- A. Refer to Division 01 Section Common Product Requirements.
- B. Basis of Design: Materials, manufacturer's product designations, and/or manufacturer's names specified herein shall be regarded as the minimum standard of quality required for work of this Section. Comply with all manufacturer and contractor/fabricator quality and performance criteria specified in Part 1.
- C. Substitutions: Products proposed as equal to the products specified in this Section shall be submitted in accordance with Bidding Requirements and Division 01 provisions.
 - 1. Proposals shall be accompanied by a copy of the manufacturer's standard specification Section.
 - 2. Include a list of five (5) projects of similar type and extent, located within a fifty mile radius from the location of the project. In addition, the three projects must be at least five (5) years old and be available for inspection by the Owner or Owner's Representative.
 - 3. Equivalency of performance criteria, warranty terms, submittal procedures, and contractual terms will constitute the basis of acceptance.
 - 4. Substitution request must be submitted by prime bidding contractor a minimum of 7 business days before Bid Due Date.

2.2 DESIGN BASED UPON

A. The design is based upon roofing systems engineered and manufactured by The Garland Company or PRE-APPROVED Equal.

2.3 DESCRIPTION

- A. Modified bituminous roofing work including but not limited to:
 - 1. One ply rosin sheet nailed.
 - 2. One ply of Stressbase 80 bonded to the prepared substrate with bitumen.
 - 2. Hot Bitumen: ASTM D312, Type III steep asphalt having the following characteristics:
 - a. Softening Point 185°F 205°F
 - b. Flash Point 500°F
 - c. Penetration @ 77°F 15-35 units
 - d. Ductility @ 77°F 2.5 cm

- 3. Base Flashing Ply: One (1) ply of SBS base flashing ply covered by an additional layer of modified bitumen membrane and set in bitumen.
- 4. Modified Membrane: Versi Ply Mineral; 145 mil SBS (Styrene-Butadiene-Styrene) rubber modified roofing membrane with fiberglass reinforced scrim.
- 5. Surfacing: Apply Pyramic, a white acrylic coating ASTM G26

2.4 BITUMINOUS MATERIALS

- A. Asphalt Primer: V.O.C. compliant, ASTM D41.
- B. Asphalt Roofing Mastic: V.O.C. compliant, ASTM D2822, Type II.
- C. Interply Adhesive: ASTM D312, Type III.

- A. Base Ply: Stressbase 80
- A. Base Flashing Ply Stressbase 80 Sheet): Dual fiberglass reinforced SBS Modified
- B. Modified Flashing Ply:
 - 1. VERSIPLY MINERAL
- C. Modified Membrane Properties (Finished Membranes): VERSIPLY MINERAL; ASTM D6163, Type III Grade G
 - 1. Tensile Strength (ASTM D5147)
 - a. 2 in/min. @ 73 ± 3.6 °F MD 220 lbf/in CMD 220 lbf/in
 - 2. Tear Strength (ASTM D4073)
 - a. 2 in/min. @ 73 ± 3.6 °F MD 300 lbf CMD 300 lbf
 - 3. Elongation at Maximum Tensile (ASTM D2523)
 - a. 2 in/min. @ 73 ± 3.6 °F MD 4.5 % CMD 4.5 %
 - 4. Low Temperature Flexibility (ASTM D5147): Passes -30 °F

2.6 SURFACINGS

- A. White Elastomeric Roof Coating: Pyramic; Energy Star approved white acrylic roof coating:
 - 1. Weight/Gallon 12 lbs./gal. (1.44 g/cm3)
 - 2. Non-Volatile % (ASTM D 1644) 66 min
 - 3. Reflectance 81%

2.6 RELATED MATERIALS

- A. Type II base sheet: Follow roof system manufacturer's wind uplift calculations.
- B. Nails: Square head roofing nails.
- C. All roof slopes greater than 2" in 12" all SBS Modified sheets must be back nailed or strapped.
- D. Urethane Sealant: One part, non-sag sealant as recommended and furnished by the membrane manufacturer for moving joints.
 - 1. Tensile Strength (ASTM D412) 250 psi
 - 2. Elongation (ASTM D412) 950%
 - 3. Hardness, Shore A (ASTM C920) 35
 - 4. Adhesion-in-Peel (ASTM C920) 30 pli
 - D. Sealant: Single component, 100% solids structural adhesive as furnished and recommended by the membrane manufacturer.
 - 1. Elongation (ASTM D412) 300%
 - 2. Hardness, Shore A (ASTM C920) 50
 - 3. Shear Strength (ASTM D1002) 300 psi
- E. Glass Fiber Cant: Continuous triangular cross Section made of inorganic fibrous glass used as a cant strip as recommended and furnished by the membrane manufacturer.

PART 3 — EXECUTION

3.1 EXECUTION, GENERAL

A. Comply with requirements of NRCA, Roofing and Waterproofing.

3.2 EXAMINATION

- A. Verify that deck surfaces and project conditions are ready to receive work of this Section.
- B. Verify that deck is supported and secured to structural members.
- C. Verify that deck is clean and smooth, free of depressions, projections or ripples, and is properly sloped to drains, valleys, or eaves.
- D. Verify that adjacent roof substrate components do not vary more than ¼ inch in height.
- E. Verify that deck surfaces are dry and free of ice.
- F. Confirm that moisture content does not exceed twelve (12) percent by moisture meter tests. On concrete deck pour hot asphalt on to deck if it bubbles / foams and once cooled does not adhere to the substrate, the moisture levels are too high.

G. Verify that openings, curbs, pipes, conduit, sleeves, ducts, and other items which penetrate the roof are set solidly, and that wood cant strips, wood nailing strips, and reglets are set in place.

3.3 DECK PREPARATION

A. Wood Deck

- 1. Verify that wood decking is flat and has tight joints.
- 2. Seal plywood joints with tape.
- 3. Fill knot holes with latex filler.

3.4 GENERAL INSTALLATION REQUIREMENTS

- A. Cooperate with manufacturer, inspection and test agencies engaged or required to perform services in connection with installing the roof system.
- B. Insurance/Code Compliance: Where required by code, install and test the roofing system to comply with governing regulation and specified insurance requirements.
- C. Protect other work from spillage of roofing materials and prevent materials from entering or clogging drains and conductors. Replace or restore other work damaged by installation of the coal tar modified bituminous roofing system.
- D. Coordinate installation of roofing system components so that insulation and roofing plies are not exposed to precipitation or left exposed overnight. Provide cut-offs at end of each day's work to cover exposed ply sheets and insulation with two (2) plies of #15 organic roofing felt set in full moppings of bitumen and with joints and edges sealed with roofing cement. Remove cut-offs immediately before resuming work.
- E. Asphalt Bitumen Heating: Heat and apply bitumen in accordance with the Equiviscous Temperature (EVT) Method as recommended by National Roofing Contractors Association (NRCA). Do not raise temperature above minimum normal fluid-holding temperature necessary to attain EVT (plus 5°F at point of application) more than one (1) hour prior to time of application. Determine flash point, finished blowing temperature, EVT, and fire-safe handling temperature of bitumen either from information by manufacturer or by suitable test. Do not exceed recommended temperature limits during bitumen heating. Do not heat to a temperature higher than twenty five degrees (25°F) below flash point. Discard bitumen that has been held at temperature exceeding Finishing Blowing Temperature (FBT) for more than three (3) hours. Keep kettle lid closed except when adding bitumen.

F. Asphalt Bitumen Mopping Rate:

1. Modified Membrane Mopping: Apply bitumen at the rate of approximately thirty (30) lb. of bitumen per roof square.

- G. Substrate Joint Penetrations: Prevent bitumen from penetrating substrate joints, entering building, or damaging roofing system components or adjacent building construction.
- H. Apply roofing materials as specified by manufacturer's instructions.
 - 1. Keep roofing materials dry before and during application.
 - 2. Do not permit phased construction.
 - 3. Complete application of roofing plies, modified sheet and flashing in a continuous operation.
 - 4. Begin and apply only as much roofing in one day as can be completed that same day.
- I. Cut-Offs (Waterstops): At end of each day's roofing installation, protect exposed edge of incomplete work, including ply sheets and insulation. Provide temporary covering of two (2) plies of #15 organic roofing felt set in full moppings of bitumen with joints and edges sealed.
- J. Broadcast minerals into the bleed out of bitumen while bitumen is at its recommended EVT temperature to achieve uniform color throughout.

3.6 BASE PLY INSTALLATION

- A. Base Ply: Install one (1) base ply sheet in thirty (30) lbs. per square of bitumen shingled uniformly to achieve one ply over the entire prepared substrate. Shingle in direction of slope of roof to shed water on each area of roof.
- B. Lap ply sheet ends eight (8) inches. Stagger end laps twelve (12) inches (304mm) minimum.
- C. Lightly broom in base ply to assure complete adhesion.
- D. Extend ply two (2) inches beyond top edges of cants at wall and roof projections and equipment bases.
- E. Install base flashing ply to all perimeter and projection details after membrane application.

3.7 MODIFIED MEMBRANE APPLICATION

- A. Solidly bond the modified membrane to the base layer with specified asphalt at the rate of twenty five (25) to thirty (30) lbs. per 100 square feet.
- B. The modified membrane roll must push a puddle of asphalt in front of it with asphalt slightly visible at all side laps. Exercise care during application to eliminate air entrapment under the membrane.
- C. Apply pressure to all seams to ensure that the laps are solidly bonded to substrate.

- D. Lightly broom modified membrane to insure proper adhesion.
- E. Install subsequent rolls of modified membrane across the roof as above with a minimum of four (4) inch (101mm) side laps and eight (8) inch end laps. Stagger the end laps. Apply the modified membrane in the same direction as the previous layers but stagger the laps so they do not coincide with the laps of the base layers.
- F. Apply asphalt no more than five (5) feet ahead of each roll being embedded.
- G. Extend membrane two (2) inches beyond top edge of all cants in full moppings of the specified asphalt.

3.8 FLASHING MEMBRANE INSTALLATION

- A. Seal all curb, wall and parapet flashings with an application of mastic and mesh on a daily basis. Do not permit conditions to exist that will allow moisture to enter behind, around or under the roof or flashing membrane.
- B. Prepare all walls, penetrations, expansion joints to be flashed with asphalt primer at the rate of one hundred (100) square feet per gallon. Allow primer to dry tack free.
- C. Use the modified membrane as the flashing membrane. Adhere to the underlying base flashing ply with specified asphalt unless otherwise noted in these specifications. Nail off at a minimum of eight (8) inches o.c. from the finished roof at all vertical surfaces.
- D. Solidly adhere the entire sheet of flashing membrane to the substrate.
- E. Seal all vertical laps of flashing membrane with a three-course application of trowel-grade mastic and fiberglass mesh.
- F. Coordinate counter flashing, cap flashings, expansion joints, and similar work with modified bitumen roofing work.
- G. Coordinate roof accessories, miscellaneous sheet metal accessory items, including piping vents and other devices with the roofing system work.

3.9 FLASHING'S

- A. Three course all flashing seams:
 - 1. Trowel grade asphalt based roofing mastic designed for use in repair and patching against leaks in asphalt based roofing systems. Product must contain plasticizing oils and resins which provide low temperature flexibility and ductility.
 - 2. SBR coated woven fiberglass reinforcing fabric to be used in all 3 course applications.

3.10 APPLICATION OF SURFACING

A. Prior to installation of surface, obtain approval from manufacturer as to work completed. 14 days are required prior to final surfacing.

B. Reflective Coatings

1. Paint all exposed roofing with manufacturer's Energy Star acrylic coating installed at a rate of four (4) gallons per square per coat in a two coat application. All coats must me back-rolled to insure proper coverage.

3.11 FIELD QUALITY CONTROL

- A. Perform field inspection and as required by manufacturer.
- B. Correct defects or irregularities discovered during field inspection.
- C. Require attendance of roofing materials manufacturers' representatives at site during installation of the roofing system. A copy of the specification should also be on site at all times.

3.12 CLEANING

- A. Remove bitumen adhesive drippings from all walls, windows, floors, ladders and finished surfaces.
- B. In areas where finished surfaces are soiled by asphalt or any other sources of soiling caused by work of this Section, consult manufacturer of surfaces for cleaning instructions and conform to their instructions.
- C. Repair or replace defaced or disfigured finishes caused by work of this Section.

3.13 CONSTRUCTION WASTE MANAGEMENT

A. Remove and properly dispose of waste products generated during roofing procedures. Comply with requirements of authorities having jurisdiction.

3.14 FINAL INSPECTION

- A. At completion of roofing installation and associated work, meet with Contractor, installer, installer of associated work, Owner, roofing system manufacturer's representative, and other representatives directly concerned with performance of roofing system.
- B. Walk roof surface areas of the building, inspect perimeter building edges as well as flashing of roof penetrations, walls, curbs and other equipment. List all items requiring correction or completion and furnish copy of list to each party in attendance.
- C. The roofing system manufacturer reserves the right to request a thermographic scan of the roof during final inspection to determine if any damp or wet materials have been installed. The thermographic scan shall be provided by the [Roofing] Contractor.

- D. If core cuts verify the presence of damp or wet materials, the Roofing Contractor shall be required to replace the damaged areas at his own expense.
- E. Repair or replace deteriorated or defective work found at time above inspection as required to a produce an installation which is free of damage and deterioration at time of Substantial Completion and according to warranty requirements.
- F. Notify the Contractor and Owner upon completion of corrections.
- G. Following the final inspection, provide written notice of acceptance of the installation from the roofing system manufacturer.
- H. Immediately correct roof leakage during construction. If the Contractor does not respond within twenty four (24) hours, the Owner will exercise rights to correct the Work under the terms of the Conditions of the Contract.

3.15 OWNER SUPPLIED MATERIALS

Contractor must include in their base bid any additional materials to complete the roofing project. Contractor must provide all labor to install owner supplied materials as part of their bid. All materials not specifically included in the owner supplied materials section will be the responsibility of the contractor to provide and install in compliance with section 07 52 00. Freight charges of Owner supplied materials will be the responsibility of the Owner. Contractor must take delivery of materials, properly cover and store at jobsite or their shop. Contractor must be able to provide certification in writing from roof system manufacturer that the contractor is approved to install the specified roof system and provide all warranty requirements of section 07 52 00. 




