**RESOLUTION #2016-17-10**

**CERTIFYING ALL PROCEEDINGS IN THE NOVEMBER 8, 2016  
GENERAL OBLIGATION BOND ELECTION**

**WHEREAS**, the Board of Education (“Board”) of the Willows Unified School District previously adopted a resolution ordering a school bond election and authorizing necessary actions in connection therewith (“Bond Resolution”), and an election to authorize the issuance of general obligation bonds was thereafter called and held on November 8, 2016 (“Bond Election”); and

**WHEREAS**, the Bond Resolution was duly delivered to the Clerk-Recorder for Glenn County; and

**WHEREAS**, notice of the Bond Election was duly given; and

**WHEREAS**, the Bond Election was duly held and conducted for the purpose of voting on a measure for the issuance of bonds of the Willows Unified School District in the amount of \$8,000,000 (“Bond Measure”); and

**WHEREAS**, the Board has received from the Glenn County Clerk-Recorder the Canvass and Statement of Results of the Bond Election (“Certificate of Election”); and

**WHEREAS**, it appears from the Certificate of Election, a copy of which is attached hereto as Exhibit “A”, that fifty-five percent (55%) or more of the votes cast on the Bond Measure were in favor of issuing the aforementioned bonds.

**NOW, THEREFORE, BE IT RESOLVED**, We, the Board of Education of the Willows Unified School District, DO HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:

Section 1. That entry be made upon the minutes of this meeting that the Bond Measure has been approved by fifty-five (55%) or more of the votes cast at the Bond Election.

Section 2. That all proceedings of the Willows Unified School District in connection with the Bond Election have been accomplished according to law.

Section 3. That the Clerk of the Board is hereby requested to deliver, or arrange for delivery of, a copy of this Resolution to the County Superintendent of Schools.
