- 4.1 Employee Associations (WUTA & CSEA) No reports.
- 4.2 Principals

MES – Stephen Montana reported:

- Back to School Night was a great success. Teachers did an amazing job of decorating their classrooms and giving presentations to the parents.
- Making really good use of the ELA program (Benchmark).
- September 13-14, 2017, Murdock PTO is sponsoring Ron's Reptiles, an assembly for all grades.
- Thank you to the Maintenance Department. They've worked tirelessly to make sure the air conditioning was being repaired.
- Enrollment at the end of 2016/17 was 612. Enrollment is now 616.

WIS – Steve Sailsbery reported:

- Volleyball is off and running.
- Back to School Night turned out very well.
- September 1, 2017, Leon Logothetis gave two presentations on kindness through his "Kindness Diaries Tour." It was very moving for the students to hear his story and his message that focused on being kind to each other. Each student was challenged to perform one act of kindness every day. He did a follow up workshop with a group of students, mainly student body representatives. WIS now has a "Kindness Club." Bibiana McNeil (school counselor) began implementing a program last spring called "Caughtcha Being Kind." All of which is to try to help alleviate bullying.
- There will be a rally on September 8, 2017.
- Magazine/Cookie Dough fundraiser will begin on September 1, 2017.
- Coffee with Steve and Ron on September 15, 2017 at 7:30 a.m., which is a casual exchange with parents.
- Enrollment at the end of 2016/17 was 345. Enrollment is now 362.

WCHS – Dr. Geivett reported:

- Enrollment is 16, with one more coming.
- Students are still working with the Willows Care Center with activities such as walks, barbecues, making bird houses/feeders, and boxes for patients. Will work on kite flying this year.
- Two former students stopped by to visit. One is attending Butte College and wants to go into law enforcement. Another student shared that she wanted to figure out a way to go to Houston to help in the hurricane aftermath. It's good to see former students wanting to make a difference.

WHS – David Johnstone reported:

- Back to School night was a good turnout.
- New teachers are off and running.
- Attended the Ag Advisory Committee meeting.
- Trying to get an after school Fire Science Academy up and running. Looking at applying for a \$35,000 grant to get the program started.
- There are CTE facility grants available that WHS is considering going after.
- Looking at new curriculum for Health and Career Ed.
- Students have started a new math club called "MEATS," with Eloise Lengyel as the advisor.
- Students are attending the after school tutorials.
- Fall sports are up and running.
- Board asked questions that led to a discussion surrounding the time for passing periods.

4.3 Associated Student Body Report – Bailey Morrell reported:

- Hosted a successful Freshman Orientation, school activities night and first rally of the year.
- Homecoming week is September 11-15, 2017. Theme is "What's Up." Candidates are Briana Briones & Austin McDonald; Mayra Licea & Nestor Chavez; Christina & Sean Carriere; and Julia Lederer & Matt Walter. Rally will be September 15th from 8:55 a.m. 9:35 a.m. Lunch will be closed campus, followed by the parade through town.
- Battle of the Axe will be held on September 22, 2017.
- Community bonfire will be held on September 21, 2017 at the WHS track.

4.4 Director of Business Services – Debby Beymer reported:

- Unaudited actuals will be presented in October.
- Budget committee meeting yesterday. Discussion surrounded replacing the computers in the computer labs at each school.
- Federal government is really hitting us hard with reductions in funding. Title I has been reduced by about \$6,000 and Title II by 50% which means about a \$50,000 reduction. U.S. Fish & Wildlife money, which is about \$36,000, is on hold.
- Senate Bill 751 is headed to the governor's desk. This is the amendment to the minimum 3% reserve requirement, which allows schools with less than 2,500 students enrolled to be exempt from those rules & regulations. This will also increase the 3% reserve to 10%.

- Federal government is cutting Title II, which is professional development money.
- Still working on ESSA.
- CDE postponed the date when test scores would be released.
- Testing calendars have been updated.

4.6 **Superintendent – Dr. Geivett reported:**

- Working with architects for bond projects to begin in Spring 2018:
 - > WHS
 - Gym, air conditioning, bleachers, revamping ADA compliant restrooms in the cafeteria, painting the school in two phases phase one will consist of all the buildings with the exception of the gym and cafeteria which will be done after construction is complete.
 - > MES
 - Portable replacement to include a toilet facility and restriping the playground.
 - > WIS
 - New toilet facility.
 - Landscaping the front of the school.
- Thank you to maintenance for working on the air conditioning issues at MES.

- Wiring completed at MES/WHS except some things GCOE needs to finish. Wireless access points need
 to be installed.
- Ongoing issue with Bay Alarm. We are refusing to pay for services we did not receive. Not happy with Bay Alarm. Debby Beymer will be working with them to craft a deal on a final payment. We are looking to solicit vendors to replace the cameras.
- Second Citizens' Bond Oversight Committee meeting was held on August 23, 2017. It's a good
 committee, who's had some good suggestions. Jim Lambert is the chair, and they will submit a report to
 the Board in the spring.
