## **MES – Stephen Montana reported:**

- End of the 1<sup>st</sup> Trimester is November 10, 2017. Report cards will go home November 16, 2017.

# WIS - Steve Sailsbery reported:

- Grade Level Team Meetings were held on October 25, 2017. Forty-seven of the 371 students enrolled were deemed to be "at risk" of not passing. Steps have been taken to help them be more successful.
- Darren Massa, a science specialist from GCOE, is working with the science teachers on implementing the Next Generation Science Standards (NGSS).

- November 13, 2017, during 3<sup>rd</sup> period, Linda Riggle and Priscilla Exeter from GCOE will be doing a prepresentation of the CTE Exploratory Day that they will be putting on in the spring. They will be meeting with the 8<sup>th</sup> graders in order to refine their presentation and to deliver some information to students and staff
- A "Fun Day" will be held on November 17, 2017.

### **WHS- David Johnstone reported:**

- Volleyball and Cross Country have made it to the Section Finals.
- The Math Club "MEATS" held a competition during lunch where 60 students participated.
- Math Coaching is continuing.
- Nestor Chavez was the recipient of the 2017 CIF Fall Spirit of Sport Award for the North Section and earned a \$500 scholarship.
- An assembly will be held on November 9, 2017, to honor all fall sports and cheer and those moving onto Section finals.

## 4.6 Superintendent – Dr. Geivett reported:

- Plans for the gym/bleachers/cafeteria/locker rooms have been sent to the Division of State Architects (DSA). It can take 6-8 weeks for a response and approval.
- Plans for MES portable replacement and restrooms and WIS restrooms will be submitted to DSA next.
- WHS painting will occur during non-school days beginning November 10, 2017 and will continue during Thanksgiving and Christmas break.
- There has been a substantial savings in the District's water bills since putting in wells at the sites. Saved over \$19,000 this past year.
- Last month the Board set aside funds for technology. Sites have begun making appropriate purchases to include Chromebook carts and wireless access points.
- Steven Permann has been working with Glenn County Public Health (GCPH) in regards to the WHS pool. The pool needs several repairs to continue being used. WUSD needs to put together a viable plan to make those repairs and submit it to GCPH in order to keep it open. The water is safe and the pool can be used pending the approval of the plan to make the repairs.

Per the discussion at the October 12, 2017, Board meeting, the Board wants to help fund the 5<sup>th</sup> grade students' attendance at Shady Creek Environmental Camp. Jennipher Dace and Amanda Haltom, 5<sup>th</sup> grade teachers at MES, shared that it costs \$240 per student for the 5 day program to attend the camp, plus transportation. This year 67 students attended, so the amount was just over \$16,000 for the camp, plus \$2,000 for transportation. This camp is a beneficial program for our students. The students have been fundraising and will continue to do so as needed. Mr. Geiger moved, seconded by Mrs. Taylor to approve setting aside \$13,000 per year for the 5<sup>th</sup> graders at MES to attend Shady Creek Environmental Camp beginning with the 2017/18 school year.
