- 4.2 **Principals**

### **MES – Stephen Montana reported:**

- All 5<sup>th</sup> grade teachers' classrooms received the \$500 Cal Water grant.
- Enrollment is 617 students. Average ADA for Month 6 was 94.77%.
- ELPAC (replacing CEDLT) testing will begin the week of February 5, 2018.
- Coffee with the Principal is scheduled for February 8, 2018.
- MES PTO Spaghetti Feed will be on February 15, 2018, from 4:30 pm 7:00 pm.
- Kindergarten Registration will be held on March 1-2, 2018, at MES. Flyers were distributed to each of the preschools. Kindergarten tours for prospective parents will be held on February 7th and 9<sup>th</sup>.
- Second trimester ends on March 2, 2018.
- MES celebrated the 100<sup>th</sup> day of school on January 30, 2018. Students and staff dressed up like they were 100 years old.

### WIS - Ron Bazan reported:

- A parent meeting was held on January 31, 2018, to go over the new Sex Ed curriculum "TeenTalk" that will be taught by April Hine from GCOE. Twenty parents attended the meeting.
- Fifteen students will be attending the Latina conference at CSU, Chico on February 2, 2018.
- Teachers visited WHS and MES last week to observe what teachers at other sites are doing instructionally.

### WCHS – Dr. Geivett reported:

• Glenn Gazette will be publishing a story in its next edition about the students of WCHS and their visits with the patients at Genesis (Willows Care Center).

#### WHS – David Johnstone reported:

- Bailey Morrell was selected as the Superior Region Star Farmer and is the regional winner of the forage production and beef production proficiency award areas. All 3 applications will move on to state scoring.
- GCOE is going to provide \$10,000 for a new laser engraver for the Ag Department.
- Information was presented on how WHS is preparing students for Butte College courses.
- Tardies have decreased since changing the bell schedule to increase the passing period from 5 to 7
  minutes and increasing the lunch hour from 35 to 48 minutes. They are continuing to look for ways to
  decrease tardies.
- The Ag Department submitted 13 state FFA degree applications, and all 13 were approved.
- Working on the master schedule for next year. Looking to add Principles of Computer Science, Drama, and AP Psychology. They are also looking to keep the block schedule for next year. Will try to minimize free periods.
- Academic Awards Assembly was held on January 26, 2018. From the many awards given out, 270 of
  463 students received awards for having a 3.0 or higher. Teacher of the month was Jen Carriere, and staff
  member of the month was Steve Permann. Eleven students had perfect attendance, and 4 names were
  drawn to receive a \$50 gift card (purchased by the WHS Boosters).
- Amanda Samons won the Region 2 High School Teacher of the Year, and will move on to the state level. The awards dinner will be held on March 2, 2018, in Sacramento.
- It's been Homecoming week, and it's been a fun week.
- Discussed effectiveness of the after school tutorial program and ways to promote it including a targeted all call and e-mails.

## 4.4 Director of Business Services – Debby Beymer reported:

- Governor's budget proposal includes fully funding all schools two years ahead of schedule. It also
  includes funding approximately \$247.00 per ADA for mandated cost reimbursement which would
  amount to about \$300,000 additional money for next year.
- Educator Effectiveness dollars have to be spent by the end of this year. Title II money has been cut in half, and the old PAR and BTSA programs are gone. Need to set aside money in a new restricted account for professional development money for teachers.

### 4.6 Superintendent – Dr. Geivett reported:

- Bond Projects:
  - Modular buildings at MES and the toilet buildings at WIS/MES have been DSA approved.
  - There is a contract with Enviroplex for the modular buildings, and they will be put in this summer. A "piggyback" agreement is in place which allows other districts in the state to use our bid for their modular buildings, and WUSD gets a small percentage of the amount. There are some administrative duties that go along with it.
  - O Awaiting DSA's final approval for the construction project at WHS (locker rooms/gym/cafeteria). Contractor should be hired by the end of this month. Bid will go out in mid-February.
- Citizens' Bond Oversight Committee (CBOC) meeting was held on Tuesday, January 30, 2018. Jim Lambert will be presenting the CBOC annual report at the next Board meeting.
- Dr. Geivett and Jim Lambert met with members of the Grand Jury on Monday, January 29, 2018, to discuss bond activities since the election. The Grand Jury will be publishing its final report in June.
- Attended the Superintendent's Symposium in Monterey.
- Congratulations to Amanda Samons for being selected the Region 2 High School Teacher of the Year.
- Thank you to the WHS Boosters for a great dinner they put on. The Boosters do outstanding things for our students.
