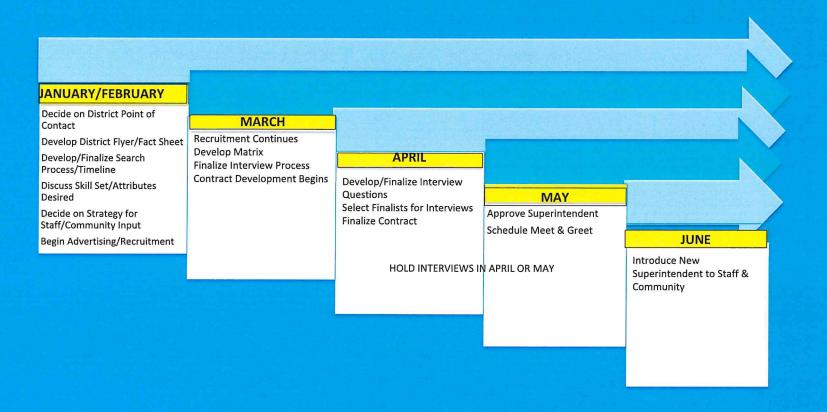

The parties agree that this Agreement is the complete agreement between the parties superseding all prior written or oral agreements between the parties. The parties further agree that this Agreement can be altered or modified only through a writing signed and dated by both parties.

We were very fortunate to have Ms. Pearson who genuinely cared about the final outcome of the search and was looking for what was best for our district and students. 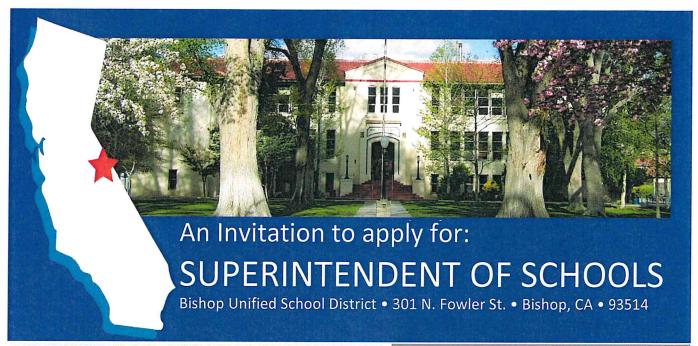

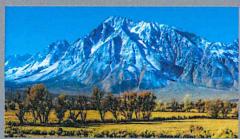
Bishop Unified School District includes:

East Nicolaus Joint Union High School District (ENJUHSD) is a single school district with one comprehensive high school. The District operates a \$3.2 million budget with an enrollment of 307, of which 34 percent qualify for free and reduced meals. The student population comes from the three surrounding elementary feeder school districts. ENJUHSD also attracts a number of interdistrict students from nine different surrounding school districts.

The 18 certificated and 12 classified staff provide the educational opportunities through comprehensive programs with both career/vocational and a college-bound focus. ENJUHSD has a 97 percent graduation rate and was awarded a 6-year WASC, which takes the district through 2024.
