employee appropriate notice. – Mr. Parisio moved, seconded by Mr. Thompson, to approve Resolution #07-08-11. Roll call vote was taken and the motion passed with 4 yes votes. Mrs. Ward was absent.

B. EDUCATIONAL SERVICES

- (Action) Consider expulsion of Student #07-08-12. Administration recommends: Student #07-08-12 be expelled from the Willows Unified School District through the end of the fall semester of 2008/09. Student will be placed in the Community Day Program until the spring semester of 2008/09. The Stipulated Expulsion Option requires Student to have periodic drug testing at no cost to the District, and complete 25 hours of community service. Mr. Parisio moved, seconded by Mr. Thompson to approve administration's recommendation. The motion passed with 4 yes votes and 1 absent.
- 2. (Action) Consider expulsion of Student #07-08-13. Administration recommends: Student #07-08-13 be expelled from the Willows Unified School District through the fall semester of 2008/09. Student will be placed in the Community Day Program until the spring semester of the 2008/09 school year. The Stipulated Expulsion Option requires Student to have periodic drug testing at no cost to the District and complete 25 hours of community service. Mr. Thompson moved, seconded by Mr. Parisio, to approve administration's recommendation. The motion passed with 4 yes votes and 1 absent.
- 3. (Action) Consider expulsion of Student #07-08-14. Administration recommends: Student #07-08-14 be expelled from the Willows Unified School District through the fall semester of 2008/09. Student will be placed in the Community Day Program until the spring semester of the 2008/09 school year. The Stipulated Expulsion Option requires Student to have periodic drug testing at no cost to the District, and complete 50 hours of community service. Student should seek and show successful attendance in a counseling program outside the District (at no cost to the District) that addresses substance abuse issues related to the misconduct that led to this expulsion action. Student is to remain away from the grounds on or adjacent to any school within the District, except the program campus of attendance or for community service hours.- Mr. Parisio moved, seconded by Mr. Thompson, to approve the administration's recommendation. The motion passed with 4 yes votes and 1 absent.
- 4. **(Action)** Second Reading for revisions to Board Policy 6146.1(a-m) Graduation Requirements. Mr. Parisio moved, seconded by Mr. Thompson, to approve the revisions. The motion passed with 4 yes votes and 1 absent.
- 5. (Action) Consider approval regarding change dates for January and June 2009 Board Meetings. (Recommend: January 15, 2009 and June 18, 2009) – Mr. Parisio moved, seconded by Mrs. Domenighini to approve changing the Board Meeting dates for January and June 2009. The motion passed with 4 yes votes and 1 absent.
