Mrs. Domenighini asked to discuss BP 1020, BP/AR 3514, BP 6141, BB 9124, and BB 9324 for two reasons. She felt the Board needed to study thoroughly the full language of the policies with options. The Board needs to have a full understanding of what is possible and what their responsibilities were. She used BB 9124 and BP 1020 as examples. Mr. Thompson moved, seconded by Mr. Geiger, to approve the Policies as presented. The motion passed with 3 yes votes. Mrs. Domenighini voted no.

3. (Action) Consider expulsion of Student #2008-09-03. Administration recommends: Student #2008-09-03 be expelled through the end of the spring semester of 2008/09. The expulsion shall be suspended and the student will be enrolled in Willows High School with conditions. If the conditions are violated, he will be placed at Willows Community High School. The student should seek and show successful attendance in a counseling program outside the District (at no cost to the District). A counselor/site administrator will review this contract with the student upon his/her return to school after signing this document. Student will not leave campus after arriving without first obtaining permission form administration. Any violation of the Stipulated Expulsion Order, which includes 20 hours of volunteer community service, will result in the Student's immediate expulsion and placement in the Willows Community High School without further Board Hearing -

Mr. Thompson moved, seconded by Mr. Geiger to accept administration's recommendation.

4. **(Action)** Consider expulsion of Student #2008-09-04. Administration recommends: Student #2008-09-04 be expelled through the end of the spring semester of 2008/09. The Student will be placed in the Willows High Community Day School. Student should seek and show successful attendance in a substance abuse counseling program outside the District (at no cost to the District). Periodic drug testing will be completed at no cost to the District. A counselor/site administrator will review this contract with the student upon his/her return to school after signing this document. Student will complete 20 hours of volunteer community service -

Mr. Thompson moved, seconded by Mr. Geiger, to accept administration's recommendation.

5. (**Discussion**) Consider changes to Exhibit 5111.11, Caregiver's Authorization Affidavit –After discussion, the Board directed the Superintendent to bring back Option 2, for vote, to the February Meeting.

#### C. HUMAN RESOURCES

(Action) Consider approval of revision of possible budget cuts for 2009/10 school year. There was
lengthy discussion on this item. Dr. Olmos explained it was an ever-changing and growing list.
Mr. Thompson shared his concerns about eliminating class size reduction and the impact it would
have on Murdock. He hoped to not make a decision on CSR until they knew the number of
retirees. There was discussion on how the number of retirees would affect the number of teachers
receiving layoff notices. Dr. Olmos explained the remaining teachers would receive more aide

time in their classes. Mr. Thompson said the elimination of CSR would be devastating to Murdock. He asked Mrs. Domenighini if she would be voting on this issue. She said she would. He said it could be a conflict of interest for her because students leaving Murdock could be going to William Finch. He said, as a parent, if the District makes the decision to eliminate CSR, he will be considering home schooling. Mrs. Domenighini disagreed that it was a conflict. Mr. Thompson replied the Board and District counsel had gone to great lengths to show there is a potential for a conflict of interest for Mrs. Domenighini. He felt they needed to heed the attorney's advice. Mrs. Brott said the subject of conflict could be brought back to a future meeting. There was more discussion on CSR. Dr. Olmos said if 9 teachers were cut at Murdock, there would be approximately 26 students per class. If 13 teachers are cut, there would be approximately 32 students per class. Mr. Thompson was concerned the quality of education would be affected. After more discussion, Mr. Geiger moved, seconded by Mr. Thompson, to approve the proposed list of cuts. The motion passed with 4 yes votes.

#### D. BUSINESS SERVICES

- (Action) Consider approval of Independent Auditors Financial Report (Matson & Isom) for WUSD Fiscal Year 2007/08. (audit is available for preview at the WUSD office.) Mrs. Skala reported the audit was a good report with no findings. Mr. Thompson moved, seconded by Mrs. Domenighini, to approve the Financial Report. The motion passed with 4 yes votes.
- 2. **(Action)** Consider approval of 2008/09 Agricultural Vocational Education Incentive Grant in the amount of \$10,000. Mrs. Domenighini moved, seconded by Mr. Geiger, to approve the Grant. The motion passed with 4 yes votes.
